- 1) Download the registration and option form from the Vidyalaya website
<https://missamari.kvs.ac.in>
- 2) Submit the scanned copy of duly filled registration and option form along with the documents required, on school admission email id admissionkvmissamari@gmail.com or submit the hard copy of registration and option form along with Xerox copy of documents in the box kept with security guard.
- 3) In the subject column of the mail sent by the candidate, mention the name of the candidate and stream.
The following documents are required:
 - i) D.O.B. certificate.
 - ii) Service certificate (if applicable).
 - iii) Residence proof.
 - iv) Mark sheet of last exam passed (CLASS XTH).
 - v) Caste Category certificate (if applicable) such as SC/ST/OBC-NCL.
 - vi) Differently abled certificate (if applicable).
 - vii) Single girl child (if applicable).
- 4) It is compulsory to mention mobile number for the registration.
- 5) It is compulsory to submit registration and option form both.
- 6) Criteria and subject combination for class XI:

N.B. 1) For filling up Service category (serial no. 2 of option form)

The following priorities shall be followed in granting admissions: -
(KENDRIYA VIDYALAYAS UNDER CIVIL/DEFENCE SECTOR)

I. Children of transferable and non-transferable Central government employees and children of ex- servicemen. This will also include children of Foreign National officials, who come on deputation or transfer to India on invitation by Govt. of India.

II. Children of transferable and non-transferable employees of Autonomous Bodies / Public Sector Undertaking/Institute of Higher Learning of the Government of India.

III. Children of transferable and non-transferable State Government employees.

IV. Children of transferable and non-transferable employees of Autonomous Bodies/ Public Sector Undertakings/Institute of Higher Learning of the State Governments.

V. Children from any other category including the children of Foreign Nationals who are located in India due to their work or for any personal reasons. The children of Foreign Nationals would be considered only in case there are no Children of Indian Nationals waitlisted for admission.
